Massachusetts Firearms Law Disqualifiers

All of the following crimes will disqualify a person from immediately obtaining an FID. However, if it is not a crime of violence, the person will be entitled to receive the FID after five years from the date of conviction or release from prison, probation or parole (whichever is longer). If this is the case, the person may only possess non-large capacity weapons with the FID card. On the other hand, if a person has been convicted (or if he or she admitted to sufficient facts to warrant a finding of guilt - even if the case was continued without a finding) of any of these misdemeanors, it will act as an automatic disqualifier for life from obtaining a LTC. In other words, if a person has been convicted of OUI he or she can never be issued a LTC in the Commonwealth.

DISQUALIFIERS FOR FID's & LTC's

The following partial list of offenses appear to meet the statutory criteria for violent crimes in Massachusetts. VIOLENT CRIME shall mean any crime punishable by imprisonment for a term exceeding one year or any act of juvenile delinquency involving the use or possession of a deadly weapon that would be punishable by imprisonment for such term if committed by an adult: (1) that has an element the use, attempted use or threatened use of physical force or deadly weapon against the person of another, (2) that is burglary, extortion, arson or kidnapping, (3) that involves the use of explosives, or (4) that otherwise involves conduct that presents a serious risk of physical injury to another.

All decisions with regard to this list are within the discretion of the Licensing Authority
