## RULES FOR A BLOCK PARTY

- 1. The closure point of intersections and cul-de-sacs must be kept clear of tables or anything other than the barricades in order to allow easy access for emergency vehicles, if necessary.
- 2. NO-ALCHOLIC BEVERAGES WILL BE CONSUMED ON THE PUBLIC STREET.
- 3. AN ON-DUTY UNIFORMED OFFICER MAY BE ASSIGNED AS A LIAISON TO THIS FUNCTION, OR MAY STOP BY ON OCCASION.
- 4. Adult supervision must be provided at all times.
- 5. All activities and games are to be conducted at your own risk.
- 6. The noise level must be kept to a minimum level not to annoy or alarm surrounding neighborhoods.
- 7. Clean-up shall be the responsibility of the applicant.
- 8. The City of Everett encourages the use of recycling receptacles for cans/bottles, paper and cardboard.
- 9. Approval will be subject to all other City ordinances and governmental restrictions.
- 10. Applicants and all event participants must comply with all other applicable city, county, state and federal regulations.
- 11. No commercialism or vendors are allowed during event hours.
- 12. No open flames are allowed in the street.
- 13. All block parties may begin no earlier than 10:00 a.m. and shall end no later than 11:00 p.m. at which time all music must end. The Chief of a Police reserves the right to establish an appropriate end time based on the neighborhood, date of event or other factors.
- 14. No tables or chairs should be placed in the vicinity of fire hydrants, near the barricades or blocking the intersection.
